President's Message

During the last week while I have been "in recliner" with the flu, I've had more time to read the news and email — the good and the bad. It's a little disjointed, but here are some of the things I've experienced.

In Colorado, an 8 year old student, born a boy, is being allowed to attend school in dresses, be called by his chosen name, and use the new unisex bathrooms that have been created. The school is distributing pamphlets about transgender identity to people who want them and is a real role-model for dealing with the issue of accepting differences.

In California, vigils were held around the state for a middle school child shot to death because of the way he dressed and acted. In England, a young boy, tormented by gender issues, took his own life.

On February 9, hundreds of supporters of gay marriage gathered in San Francisco City Hall to support a fund raiser for Equality California. The *Let California Ring* campaign is going strong and *Decline to Sign*, a movement to keep an anti-marriage initiative from getting on the ballot, is getting underway.

Yesterday, I received a pre-recorded phone call. A pleasant-sounding woman urged me to please sign the petition to get a constitutional amendment making sure that marriage remained between one man and one woman on the November ballot. If I wanted to sign, I could press 1. When I did, she told me to watch for the bright green envelope coming soon, and to sign and return it right away so that they would get the 700,000 signatures necessary. She very quickly listed the groups supporting this effort, and among them was Focus on the Family, and many similar national organizations which are pouring millions of dollars into this campaign. They obviously aren't just targeting known conservatives or people in conservative communities. It looks like any listed phone number and address in California is a potential hit. No standing in front of Walmart or going door to door this time — the stakes are too high.

As I hung up the phone, my stomach knotted, and anger welled up for the second time this week. The other occasion being when Kenneth Starr (think impeach Clinton), attorney for the anti-gay marriage churches, was quoted in Monday's Chronicle in an article discussing the State Supreme Court hearing on March 4th where they will hear arguments on the constitutionality of our present law. I know you've all heard and read the arguments a hundred times.

It's hard to not make the connection between fighting against gay marriage and a classroom murder. When a group is maligned so publicly, there will be individuals who feel their disgust or hatred is validated. Those people will make the leap from disgust to violence.

I have such love and respect for PFLAG, for people who are joined to make families stronger and to improve the world for every-

PFLAG Support Meetings

Monday, March 10 in Redwood City
 Wednesday, March 12 in San Jose

Larry Courtney will be our speaker at both support meetings. He will describe his feeling of loss at the murder of his life partner, Eugene Clark on September 11, 2001 in New York City. He will also discuss the subsequent fight for the Workers Compensation Death Benefits of a Domestic Partner. During that fight, supported by Lambda Legal Defense and Education Fund, he was interviewed by Katie Curic on the "Today Show", Anderson Cooper at NY1, and Dan Abrams when Courtney spoke before the New York City Council Meeting. The final result of his six month struggle was a ruling that he should receive the death benefits of his partner as a spouse, pursuant to the new law in New York State allowing Domestic Partners of victims of the 9/11 homicides to receive spousal benefits. He was subsequently honored by NGLBT as "Person of the Year" in 2002 for his victory.

He will also touch upon the new fight in California, *Let California Ring!* concerning marriage equality.

Same-sex marriage supporters will have their day in court March 4 when the California Supreme Court will hear arguments about whether a state law defining marriage as between one man and one woman deprives LGBT individuals of their guaranteed rights.

PFLAG Scholarships Available

Each year our chapter offers scholarships to high school seniors from San Mateo and Santa Clara Counties whose educational history, personal plans and activities demonstrate support for justice and equality for gay, lesbian, bisexual and transgender persons. This year we will award four \$2,000.00 scholarships. Any graduating seniors (LGBTQ and allies) may apply.

San Jose/Peninsula PFLAG scholarships provide financial support for high school seniors who will be attending an accredited two- or four-year college, university, or business/technical school in Fall 2008. The awards are provided with the understanding that the funds will be used to offset the costs of tuition, books, or required fees.

Candidates must meet the following criteria:

- You are a high school senior at a public or private school in San Mateo County or Santa Clara County, and you will be attending an accredited two- or four-year college, university, business/technical school full- or part-time in Fall 2008.
- You have included a personal essay discussing how you have demonstrated support for gay, lesbian, bisexual and transgender persons in your community, a brief description of your career plans and informed us of any special needs or other factors you wish us to consider.
- You are in good academic standing with your current high school.
- You have provided a copy of your high school transcript and you will provide a copy of your college/university/ business/technical school acceptance letter and proof of enrollment prior to the receipt of the scholarship money.
- You have provided at least two letters of recommendation (e.g. counselor, teacher, other.)
- We ask that you be present to accept the scholarship at a San Jose/Peninsula PFLAG awards event in May, time and place to be announced.

Payment of the scholarship will be after receipt of satisfactory college/school enrollment. Deadline for scholarship winners to turn in their proof of enrollment is December 31, 2008. Scholarship winners will be notified by telephone and in writing.
