## President's Message

I tried to come up with a topic that isn't Prop. 8, but that seems to be all I can think about these days. So I will try a little levity. The following is a letter that was in the *San Francisco Chronicle* on September 19th.

"Editor- A peanut butter and jelly sandwich is not a peanut butter and jelly sandwich without either the peanut butter or the jelly. It does not take a law license or a religious preference or a high IQ to understand this. In fact, even a child can recognize basic reality, often better than we adults. In the same way, a 'marriage' that lacks a husband or wife is not a marriage. Whatever it may be, it is not a marriage. And calling it so does not make it so, unless we are willing to delude ourselves."

I want to write back to this gentleman and say that there are people who don't eat peanuts and people who don't eat sugar — but just peanut butter, or just jelly can make a very good sandwich. I also want to tell him I'm sorry if his marriage is like a peanut butter and jelly sandwich. The gay and lesbian marriages I have seen since June are more like champagne and good chocolate, or lobster and artichokes, or whatever wonderful, delicious foods you can imagine.

On September 19th we attended the Annual BAYMEC Dinner where Shannon Minter, the lawyer who argued the case for marriage before the State Supreme Court, spoke. It was electrifying. I could understand in a small way, how the people who were at the presidential conventions must have felt when their candidates spoke. Hearing from the man who was there and who gained these rights for all GLBT people in our state, that the judges ruled not only to allow the freedom to marry, but that any laws applying to GLBT people had to pass the same strict scrutiny as laws for other minorities, was indeed joyous. The power of that moment can never be taken away—although the protections will be seriously undermined if Prop 8 passes.

Saturday, Bob and I went around our neighborhood knocking on doors. Anxiety almost kept me at home, but once we started we found that many people on our street whom we hadn't met were very supportive. We were able to place 6 yard signs, and made lots of new acquaintances. As I spoke with one neighbor, her husband was in Marin County, filming an ad for No On 8 — a small world!

And on Sunday, at the UU Church in San Mateo, 16 of us had great phone conversations, identifying 86 NO voters and explaining to many what this proposition is all about.

New phoners are desperately needed. Phone banks are now operating every night from San Jose to San Francisco. I hope many of you will join our volunteer base.

Please, talk to all your friends, neighbors, family, strangers, everyone. Thanks for all you're doing.

## Statement on Proposition 8 by the Episcopal Diocesan Bishops of California

On September 10, California's six highest Episcopal Bishops went on record to oppose Proposition 8, the fall ballot measure that would reverse the California Supreme Court's May 15th decision, and eliminate the right of same-sex couples to marry.

Here is an excerpt of their letter:

As Episcopal Bishops of California, we are moved to urge voters to vote "No" on Proposition Eight. Jesus calls us to love rather than hate, to give rather than to receive, to live into hope rather than fear.

Proposition Eight would reverse the [California Supreme Court's May 15, 2008] decision and withdraw a right given. Proponents of Proposition Eight have suggested that this amendment to the Constitution would protect marriage. We do not believe that marriage of heterosexuals is threatened by same-sex marriage. Rather, the Christian values of monogamy, commitment, love, mutual respect and witness of monogamy are enhanced for all by providing this right to gay and straight alike. Society is strengthened when two people who love each other choose to enter into marriage, engaged in a lifetime of disciplined relationship building that serves as a witness to the importance of love and commitment.

We believe that continued access to civil marriage for all, regardless of sexual orientation, is consistent with the best principles of our constitutional rights. We believe that this continued access promotes Jesus' ethic of love, giving, and hope.

When Alfred Kinsey did his groundbreaking research into human sexuality, he discovered that almost half the population could be categorized as bisexual.

Yet this orientation is little understood, in part because it tends to be hidden by circumstance. Most likely, you know many people who are "bi" but appear to the public eye to be either heterosexual or gay/lesbian. This is a program for anyone of any sexual orientation who is interested in questions of sexuality, identity, or culture; who wants to acquire the knowledge and language needed to counter assumptions and stereotypes they may hear; and who shares the dream of making our community more just and welcoming to all.

You can expect to be surprised, to laugh, to cry, to be uncomfortable, to learn, and to be moved to act, all within a safe, friendly, and fun setting. Because continuity is important for creating trust and comfort in the group, please commit to attending all four sessions.

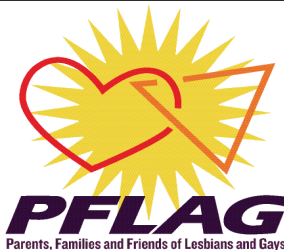

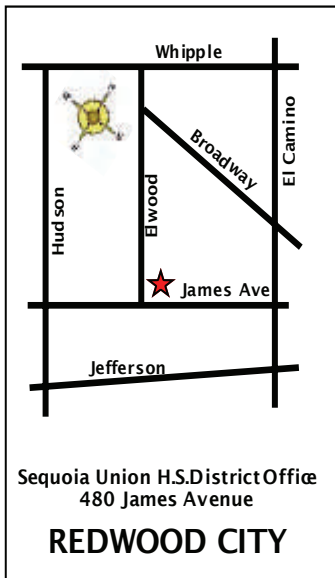

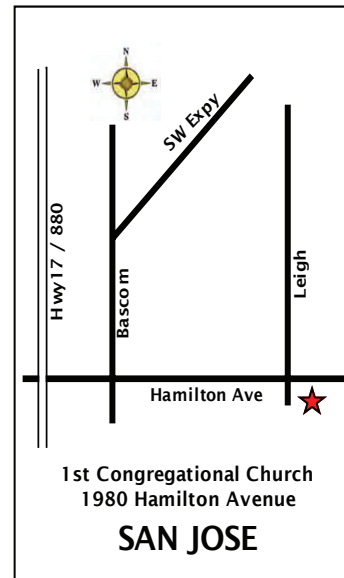
