## President's Message

Last week I was helping register voters at the San Carlos Farmer's Market and was next to Marriage Equality's table. I was really impressed by the number of straight parents with their children who came by to make donations and purchase buttons and bumper stickers.

For the last couple of years we have been talking about PFLAG's program, Straight for Equality. I think all of us realize the importance of having straight allies to accomplish our goals of full equality for LGBT persons. The goals of PFLAG's program are to educate the straight populace about what it means to be a straight ally — about the fact that one doesn't have to be political or an activist — one can do whatever small things fit within one's comfort zone. The program helps people identify what barriers they have to coming out as an ally, and show them ways to overcome them one step at a time.

PFLAG National is starting a new program, Straight for Equality in Faith Communities. Several of us attended the first training in the area for this program in August. Jean-Marie Navetta, the woman who is doing the training workshops (and is wonderful!) has just moved to San Francisco with her wife, so we have her right here to help us. My question to you is, do you belong to a faith community where hearing people's stories might help the membership to be more open to talking about GLBT issues? Maybe some people are accepting, and others aren't there yet. Or perhaps most people are OK with it, but could use a push to becoming strong allies.

Jean-Marie would be happy to help us start a program in your faith community if you are comfortable enough to work out plans with the powers that be to act as our "in" to bring a PFLAG panel to your congregation. Just let me know, or contact any of us if you'd like to discuss it further.

Remember, as a parent, family or friend, you are a straight ally and have a special voice to speak out for equality and against prejudice. "That joke offended me. I have a gay son, daughter, friend, who I really care about." Keep telling your stories — everyone!

For everyone in PFLAG, helping to keep our PFLAG chapter active is a way to promote healthy families and work for acceptance and full inclusion in our society for all GLBT people. Look inside the newsletter for ways that even over-committed people can do a little something to help.

## MA Ruling Declared DOMA Unconstitutional

On August 18, Federal Judge Joseph Tauro entered his judgment in a case challenging the Defense of Marriage Act in Massachusetts, stating that DOMA, which defines marriage as between one man and one woman, is unconstitutional, and starting a 60-day clock for the Justice Department to decide whether to appeal his ruling. The end of the 60 days falls on Oct. 11, National Coming Out Day.

Judge Tauro also approved a stay for his ruling, pending appeal. The plaintiffs, represented by GLAD, didn't fight the stay. GLAD said the stay is in its clients' best interests, adding that only a "final victory" ensures that they will have access to the Social Security and other benefits of their spouses. ▼

## Judge Walker's Historic Decision on Prop 8 Excerpt

### CONCLUSION

Proposition 8 fails to advance any rational basis in singling out gay men and lesbians for denial of a marriage license. Indeed, the evidence shows Proposition 8 does nothing more than enshrine in the California Constitution the notion that opposite-sex couples are superior to same-sex couples. Because California has no interest in discriminating against gay men and lesbians, and because Proposition 8 prevents California from fulfilling its constitutional obligation to provide marriages on an equal basis, the court concludes that Proposition 8 is unconstitutional.

Because Proposition 8 is unconstitutional under both the Due Process and Equal Protection Clauses, the court orders entry of judgment permanently enjoining its enforcement; prohibiting the official defendants from applying or enforcing Proposition 8 and directing the official defendants that all persons under their control or supervision shall not apply or enforce Proposition 8.

IT IS SO ORDERED.

Chief Judge Walker has issued a temporary stay until the 9th Circuit makes their decision in December. So we're all still waiting — "waiting for the world to change!"

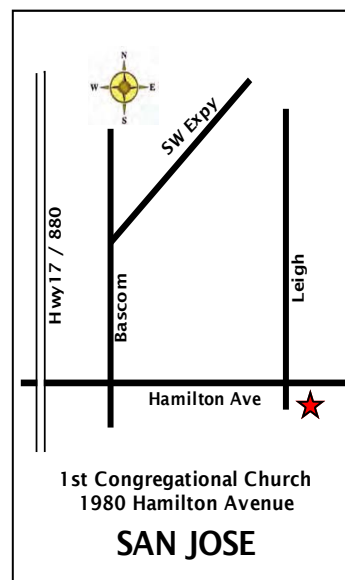
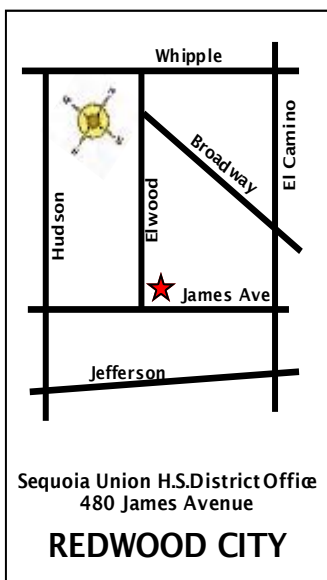
